# **Terms and Conditions**

Effective Date: April 8 2025

These Terms and Conditions ("Terms") govern your access to and use of the **CashSplash** Telegram Mini App ("App"), a reward-based platform operated by CashSplash ("Company", "we", "us", or "our").

By using CashSplash, you ("User", "you") agree to comply with and be bound by these Terms. If you do not agree, please do not use the App.

## 1. Eligibility

## 2. How the App Works

Rewards are accumulated as telegram stars and can be redeemed through designated withdrawal methods, including Tipalti.

#### 3. Account and Authentication

- We use **Telegram Authentication** to sign up and log in users.
- You are responsible for maintaining the confidentiality of your Telegram account.
- You must not impersonate others or use the platform for unauthorized or illegal purposes.

#### 4. Rewards and Withdrawals

 Telegram Stars can be exchanged for real-world currency, subject to verification and eligibility.

- All withdrawals are processed through **Tipalti**, our payment partner.
- We reserve the right to delay, deny, or revoke rewards if fraudulent, misleading, or invalid activity is detected.

## 5. Prohibited Activities

You agree NOT to:

- Use VPNs, bots, emulators, or any software to manipulate your activities or impersonate devices.
- Engage in fraudulent behaviour such as fake installs or false registrations.
- Attempt to reverse engineer or interfere with the App's functionality.
- Violate the terms of service of third-party platforms (e.g., the apps you are asked to install).

# 6. Advertising and Third-Party Links

- We use **Meta**, **Google Ads and other Ad platforms** to serve ads and offers.
- Offers in the app may lead to third-party websites or apps. We are not responsible for the content or security of those platforms.
- Your interactions with third-party advertisers are solely between you and the third party.

## 7. User Data & Privacy

- Your privacy is important to us. Please refer to our Privacy Policy to learn how we collect and use your data.
- With your consent, we may collect usage data to personalize your experience and ensure rewards are properly assigned.

## 8. Intellectual Property

All content, branding, trademarks, and code associated with CashSplash are the property of the Company or its licensors. You may not:

- Copy, modify, or distribute any part of the App.
- Use our brand assets without prior written permission.

#### 9. Termination

We may suspend or terminate your access if we detect:

- Legal obligations or platform policy violations

Any earned but unclaimed rewards may be forfeited upon termination.
